Description:	<p>Dear Parents and Caregivers,</p> <p>On Monday 30th June 2025, Wentworthville Public School will be holding the annual school Athletics Carnival at Barton Park, North Parramatta. The cost of the carnival is \$10 per student. Students will travel by bus to and from Barton Park. The carnival is an all-day event for students in Years 2-6. Students in K-1 will be returning to school earlier at approximately 1.30pm. The Athletics Carnival will commence at 9:30am. All students in K-6 will need to arrive at school by 8:55am to ensure class rolls are marked before travelling by bus to the carnival. Parents are welcome to attend the Athletics Carnival.</p> <p>Students will need to bring on the day: a hat, sunscreen, plenty of water and healthy snacks. Students are to wear running shoes/sneakers. Metal spikes are not permitted. School sports uniform should be worn. It is important that students bring their own lunch and water on the day as no canteen will be available. Students are encouraged to bring a picnic rug to sit on in their designated house area.</p> <p>The carnival will be organised and run by school staff with assistance from Sports in School Australia (SISA) staff. The Athletics Carnival is a compulsory school event that aligns with the PDHPE syllabus and has been approved by the Principal. Concussion Clearance

The Australian Medical Association recommends students being symptom-free of concussion for 14 days before returning to sport.

- If your child/ward sustains a concussion, or experiences any concussion symptoms, in the 14 day period prior to the event commencing, you must report this to supervising teachers, and a medical clearance is required in order for your child/ward to participate in the event.
- Medical clearances can be attached to this consent form or can be submitted to supervising teachers separately.

Parent/Carer Acknowledgment and Consent

- I have read the information provided in the itinerary and I hereby consent to my child/ward participating in this excursion.
- I acknowledge that this excursion is required to be held in accordance with any current NSW Health COVID-19 Public Health Orders and the NSW Department of Education's policies and procedures.
- I acknowledge and accept that there is a risk that my child/ward may be exposed to COVID-19 whilst attending and participating at this excursion.
- I confirm that my child will not attend if displaying symptoms of illness, and/or if directed to isolate under public health orders.

- In the event of any accident or illness, I authorise the obtaining, on my behalf, of an ambulance and any such medical assistance that my child/ward may require. I accept full responsibility of expenses incurred.
- I acknowledge that if my child/ward sustains a concussion, or experiences any concussion symptoms, in the 14-day period prior to the excursion commencing, I am required to report this to the organising teacher. I further acknowledge that, should this occur, my child/ward will only be permitted to participate in the planned activities, if a medical clearance is provided.
